MINUTES OF REGULAR SESSION OF THE CITY OF FRANKLIN CITY COMMISSION

August 23, 2021

The Franklin, Kentucky City Commission met in Regular Session at 12:00 Noon, Monday, **August 23, 2021**, in the City Hall meeting room located at 117 West Cedar Street, Franklin, Kentucky.

Mayor Dixon called the meeting to order at 12:00 Noon, and John Whittaker from the Franklin First Baptist Church offered the opening prayer.

APPROVAL OF MINUTES

Motion was made by Commissioner Bennett and seconded by Commissioner Williams to approve the minutes as presented the August 9, 2021, Regular Meeting and the August 16, 2021, Special Called Meeting of the Franklin City Commission.

Voting Aye by Roll Call: All. Motion carried unanimously.

GENERAL GOVERNMENT

City Manager Kenton Powell asked the Commission to consider a street closure request for the upcoming Pop Out Black Out event on Saturday, September 11, 2021. Event organizers requested to close John J. Johnson Avenue from Walker Street at Alpha Baptist Church to

Jackson Street at the Brooks Wright Center from 9:00 a.m. until 6:00 p.m. This request was tabled by the Commission at the August 9, 2021, meeting when the Commission requested additional information and confirmation of notification to residents who live within the closure area. After speaking with event organizers, Powell asked the Commission to reconsider the request.

Motion was made by Commissioner Powell and seconded by Commissioner Stewart to remove this agenda item from the table and proceed to take action.

Voting Aye by Roll Call: All members present. Motion carried unanimously.

Motion was made by Commissioner Powell and seconded by Commissioner Williams to close John J. Johnson Avenue from Jackson Street to Washington Street on Saturday, September 11, 2021, from 9:00 a.m. until 6:00 p.m. for the 2nd Annual Pop Out Black Out Festival contingent on approval from all residents within the closing area.

Voting Aye by Roll Call: All members present. Motion carried unanimously.

City Attorney Scott Crabtree asked the Commission to consider sponsorship of a proposed ordinance to adopt amendments to the Franklin-Simpson Planning & Zoning regulations. As required by statute, the F-S Planning & Zoning Commission held a public hearing on June 8, 2021, regarding these proposed amendments which were subsequently approved by the F-S Planning & Zoning Commission and City Commission approval is required to fully adopt these amendments.

Commissioner Powell and Commission Stewart asked to sponsor Ordinance No. 2021-021 with first reading taking place during the ordinance portion of this meeting.

City Attorney Scott Crabtree asked the Commission to consider adoption of a resolution recognizing September as City Government month.

Motion was made by Commissioner Bennett and seconded by Commissioner Powell and was unanimously approved by roll call vote Resolution No. H-2021 as follows:

RESOLUTION NO. H-2021 CITY OF FRANKLIN

WHEREAS, civics education in Kentucky schools is important to ensure future generations are engaged and involved in their local community and its governance;

WHEREAS, elementary schools are a prime location for the introduction of local government principles and responsibilities;

WHEREAS, involving and informing students of local government programs and duties can provide an opportunity for entire families to connect with vital city services and programs;

WHEREAS, there are 416 cities in Kentucky and 55 percent of the state's population lives in a city;

WHEREAS, "City Government Month" is a civics awareness campaign that educates elementary school students about city services by providing teachers lesson plans, a coloring/activity book and an implementation guide;

WHEREAS, "City Government Month" calls on city officials to get involved in their local schools and in educating and engaging elementary school students in city government; and

WHEREAS, the Kentucky League of Cities Board of Directors has declared September 2021 as City Government Month in Kentucky;

NOW THEREFORE, BE IT RESOLVED that the City of Franklin does hereby designate September 2021 as "City Government Month" in the city.

BE IT FURTHER RESOLVED, that city officials and employees are encouraged to collaborate with local elementary schools to educate students about their city government and to engage them in city services.

Community Development Director Tammie Carey asked the Commission to consider approval of video/web-based security awareness training by KnowBe4 for all City employees who utilizes a computer or any type of electronic devise. This training is designed to combat the threat of cyber-attacks and ransomware attacks.

Motion was made by Commissioner Stewart and seconded by Commissioner Bennett to enter into a 36 month contract with KnowBe4 in the amount of \$5,218.83 for employee video/web-based security awareness training and further authorized the Mayor to sign any and all necessary documents for this contract.

Voting Aye by Roll Call: All members present. Motion carried unanimously.

Community Development Director Tammie Carey asked the Commission to consider approval of requests for real property tax moratorium for Historic Downtown building owners pursuant to Ordinance No. 2018-006. These moratoriums would be for City real property tax years 2021 through 2025 with valuations based on the purchase price.

Motion was made by Commissioner Powell and seconded by Commissioner Stewart to approve the request for the tax moratoriums for property located at 113 and 115 West Cedar Street, 113 South Main Street, 114 North Main Street and 100 North Main Street for a period of five (5) years beginning with the 2021 tax year and ending with the 2025 tax year, and further authorized the Mayor to sign the Application for Assessment Moratorium Certificate for each property.

Voting Aye by Roll Call: All members present. Motion carried unanimously.

City Finance Director Carol Riggenbach asked the Commission to consider approval of the audit engagement with Kirby & Moore, CPAs for the fiscal year 2020-2021 financial audit. Riggenbach anticipated fieldwork to begin in September.

Motion was made by Commissioner Bennett and seconded by Commissioner Williams to approve the audit engagement with Kirby & Moore, CPAs for fiscal year 2020-2021 and further authorized the Mayor to sign any and all documents necessary for the audit.

Voting Aye by Roll Call: All. Motion carried unanimously.

City Finance Director Carol Riggenbach provided the Commission with the City's fiscal year 2021 financial performance and discussed a new format for the financial statements. The new format provided a more effective overview for City revenues and expenditures by department. The Commission expressed their support for the updated format and indicated it provided a more accurate and comprehensive overview for reporting.

No action was taken by the Commission regarding this matter.

PUBLIC SAFETY

City Manager Kenton Powell asked the Commission to consider entering into an agreement with Arnold Consulting Engineering Services, Inc. to provide geotechnical technical engineering services for the new Franklin Police Station to be located on West Madison Street.

Motion was made by Commissioner Stewart and seconded by Commissioner Williams to approve entering into an agreement with Arnold Consulting Engineering Services, Inc. in the amount of \$7,500.00 and further authorized the Mayor to sign any and all necessary documents related to this service.

Voting Aye by Roll Call: All members present. Motion carried unanimously.
