ORDINANCE NO. 2015-002

ORDINANCE AMENDING ORDINANCE NO. 151.0-1999 DATED JULY 12, 1999 WHICH ESTABLISHED THE FRANKLIN-SIMPSON INDUSTRIAL DEVELOPMENT AUTHORITY; THIS AMENDMENT ADDRESSING THE NUMBER AND MAKE UP OF THE FRANKLIN SIMPSON INDUSTRIAL AUTHORITY BOARD MEMBERS

WHEREAS, the Simpson County Fiscal Court and the City of Franklin jointly established the Franklin-Simpson Industrial Development Authority pursuant to the terms and provisions of KRS 154.50-301 to 154.50-346 to provide a coordinated effort to promote economic development on a sustained basis for Simpson County, Kentucky and the City of Franklin, Kentucky;

WHEREAS, the Simpson County Fiscal Court passed an ordinance on December 30, 2014 to amend the number of board members to eight (Ordinance No. 920.93);

WHEREAS, the Board of Commissioners of the City of Franklin desires to also join the Fiscal Court in the amendment of the number of board members on the Franklin-Simpson Industrial Development Authority;

NOW, THEREFORE, be it ordained by the Board of Commissioners of the City of Franklin, Kentucky as follows:

Paragraph 3(A) of Ordinance No. 151.0-1999 shall be amended to read as follows:

- "3. The Franklin-Simpson Industrial Development Authority shall be governed by a board composed as follows:
 - A. Eight members, four of whom shall be appointed by the Mayor of Franklin, and four by the Simpson County Judge Executive."

If any section, subsection, sentence, clause, or phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions.

All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
